MINUTES OF THE ANNUAL CONGREGATIONAL MEETING, 1-27-2019

Attendance has been taken. Quorum was determined at 33 members. There are 72 members in attendance this morning.

- 1) Call to order and opening prayer by Pastor Liliana.
- 2) The minutes from the annual meeting of 2018 are approved.
- 3) Bonnie Brown, council president and Pastor Liliana gave their reports. Members are referred to the Annual Report for details. Here are the highlights. The celebrations to recognize include the calling of Pastor Liliana and implementing many of the RFT recommendations. Our financial situation has improved. We have become a "no plastic" church. We have a new logo, an improved website. The Memorial Garden has been revitalized. This all happens through the efforts of SO MANY volunteers who remain largely invisible.
- 4) Amy Simper gave the treasurer's report. We are in the black for 2018. We are in a strong financial position. Amy also presented the budget for 2019. The membership recognized Amy for the HUGE amount of work she has done.
- 5) Dave Domzal presented the Legacy Gift Fund, a legacy gift committee, different from the Endowment Committee. This policy and the accompanying change to our constitution was developed in close conjunction with the ELCA representative from the Synod. The constitution amendment comes as a recommendation from the council. The motion to amend the constitution to include the Legacy Gift Fund was passed.
- 6) The 2019 budget as presented, was adopted.
- 7) Ferol Menzel presented the various elections. For council, Bonnie Brown, Greg Wright, Amy Simper, Linda Wakefield, and Ben Little. For the Charitable Endowment Team, Claire Clark and Ron Gebhartsbauer. For the Legacy Gift Fund, Sally Brown and Peggy Hiller. For the Nominating Committee, Sheralyn Bratlien, John Kidd, Kenyon Kugler, and Ferol Menzel. To represent LOTM at Synod Assembly, Donna and Mark Clark. The votes for all these elections were passed.
- 8) The membership expressed gratitude for the work of Dennis Boyd, many years of service on the Charitable Endowment team. Also, for the long service of Darlene Muschett to LOTM. Also, for the collaborative leadership of the church council.
- 9) Closing Prayer and adjournment at 11:25.

NEW IMPROVEMENTS TO LOTM

PRAYER LABYRINTH

Our beautiful flagstone prayer labyrinth was completed this fall and buried now in snow across from the playground. Final touches on landscaping will come this spring. The prayer labyrinth project was completely funded with donations mainly in memory of Paul Hage.

As we move into exploring new and diverse ways of practicing a deeper spirituality, the labyrinth is an important tool to share with each other and our Summit County community.

Thanks to Jamie McCluskie for his many hours of design and project supervision with contractors and Greg O'Neill for coordinating efforts, moving it forward and actually moving dirt!

AUDIO/VIDEO SYSTEM (SOUND SYSTEM)

This year LOTM moved into the modern technology era with a new audio/video (sound) system. To better describe the system, the name "audio/video system" (AV system) will now be used in place of "sound system".

A donor, who with hearing issues, came forward and proposed this new system. A committee of Bonnie Brown, council president; Greg O'Neill, facility chair; Bill Kyrioglou, sound chair; Barry Rumuck, hearing aid experience; Donna Clark, council member and music expert; and Pastor Liliana analyzed the problem, explored our options, sought bids & plans from vendors, and visited sites. And so, like a pebble thrown into a lake, a ripple effect went out.

The audio/visual system replacement meant more than new microphones. AV Colorado in Denver designed and installed the sound system components and video monitors. They worked with Assist2Hear who specializes in hearing loop (t-coils) installation to integrate their hearing aid assist system with the new audio system.

The Church Council felt it was important to meet our mission statement of inclusiveness for all, meaning our members and visitors with hearing difficulties. As with any home improvement project, this led to a more expansive project requiring new carpet in the Sanctuary. Hearing T-coils are laid in the floor, which given our situation, meant removing and replacing the carpet. Hearing aid assist devices for those people who do not have t-coil technology in their hearing aids were also purchased. A monitor screen was installed on each side of the Sanctuary so we may display videos and still pictures to enhance worship and meetings. Our own group of silent saints donated their time by installing and reconfiguring much of the wiring.

As the ripples went out, new team members became necessary to oversee the installation of the system and make the system work! We now have an **audio/video team** of Donna Clark, Nick Keelan, Bill Kyrioglou, Bruce Buehner, Karl Hegewald, Jessica Hegewald, and David Walters that keep us hearing and viewing every Sunday! They have the new wireless microphones, face mics, and wired mics working with the aid of a new laptop, iPad, and state-of-the-art audio system. New cameras and a video operating system have been installed to improve our recording

and live streaming of our Sunday worship service. Security of the sound room has been improved.

Making a complex, modern new system work smoothly is an on-going task, so the team is continually problem-solving glitches in the system. The Church Council approved hiring a consistent AV (audio/video) assistant to work with a LOTM team member volunteer each Sunday. The position was designed to be a scholarship program for a young person with passion and talent in this area. David Walters is working in this position.

Total cost of the audio/video system (excluding Sanctuary carpet) was totally covered through generous donations. Hours of time and talent have made this needed project a reality!

PRESCHOOL EXPLORATION

After an idea sparked at the July Church Council meeting, I began exploring the possibilities of a preschool/child care center housed at LOTM. Reasons for exploring this option were the following:

- There is an extreme need in the county for child care. As of November, there were 346 unduplicated names on waitlists at the "big 5" centers throughout Summit County. Fifteen years ago, there were 44 family child care homes; today there are 14 licensed family child care homes in Summit County.
- A center will bring in young families to LOTM.
- We have a fabulous space for this facility. Current programs in our downstairs would be maintained with adjustments.

During the fall, I engaged in conversations with the following individuals:

- State child care licensing representative. We walked through our downstairs space and discussed our options with the current space and needs for updates to meet licensing requirements. Greg O'Neill, building chair, has been involved in discussion of our facility and changes that may be necessary.
- Open Arms Preschool at Christ Lutheran Church here in Summit County. From them, I
 pulled operating expenses and learned about their start up process and gathering
 congregational support.
- Director of Timberline Learning Center, recently created child care center. We discussed the steps required to create a center.
- LOTM members, Rosie Tronnier and Bill Kellstrom, who both had experience with church preschools.

Confirmation was received from the Town of Dillon that a child care center would fall within current zoning requirements and, if we wanted to take a few parking spots for a playground, that would still be within requirements. The committee explored costs of a new playground and adding plumbing into proposed classrooms.

The spreadsheet on the following page outlines options and costs.

After our third committee meeting in October, we realized that we needed to gauge congregational support before moving forward. If there is support, next steps would be the following:

- Gain committee members
- Form a non-profit
- Identify funding for start-up costs
- Monitor the opening of new centers in Summit County

TREASURER REPORT

Amy Simper

Final 2019 Financial Status

- A \$368,981 2019 budget was balanced and approved by the Church Council.
- The 2019 financial situation concluded in the black with higher than expected income and lower than expected expenses. Increased loose plate offerings and unpledged income contributed greatly to LOTM's strong fiscal year.
- Excess 2019 income allowed us to fund the 2020 "Boiler Replacement Fund", create a
 Youth & Family Coordinator position, develop a focused New Member Development
 program, fund an additional contribution to Synod in 2020, provide money to improve
 parking lot lighting, and increase both council and music reserve accounts for future
 programming needs.
- The 12/31/19 building mortgage balance was \$308,672.55.

Proposed 2020 LOTM Budget

- 97 individuals or family units pledged a total of \$321,395 for 2020. Of the 97 pledges, 16 were from first-time pledgers to LOTM and 42 were increased pledges from 2019.
- Total income and expenses are projected to be \$394,620 for a balanced budget.
- Council reviewed and continued to address RFT recommendations and church needs by recommending a budget which includes a 3% raise for all staff positions, an increase in Synod benevolence funding, plans to hire a part-time Youth & Family Coordinator, funds for a New Member Development program, increases in fellowship and Christian education as well as handling normal inflation in the day-to-day operational and administrative costs to operate the church.

SUNDAY SCHOOL

Sunday School for children ages three to ten happens during Sunday worship service. Lessons are prepared by Pastor Liliana and Cindy Massaro and taught by a team of volunteers. Christy Reinking leads the children in singing. There are approximately 25 children on our Sunday School list, but attendance varies greatly each week.

Beginning with the lighting the candle and a blessing song, the format of the Sunday lessons varies, but always ends with a blessing before re-joining their families for communion. The Sunday School time may be a mixture of stories, Godly Play activities, crafts, games, flannel board stories, and videos.

CAMP COMPASSION

Camp Compassion is a partnership with Rainbow Trail Lutheran Camp that is a fun and faith formative experience that nurtures relationships between the adults and children within the church. Camp Compassion is a relational and high-energy ministry. RTLC staff led energetic games, singing, and provided guidance in leading Bible study and arts and crafts. This wonderful partnership allows for learning and relationships in the congregation to continue even after RTLC staff have departed.

We had 40 total campers; 26 entering Kindergarten- 6th grade and 14 preschoolers. There is a reasonable charge to participate, however, scholarships are available.

Junior counselors helped to build relationships with the campers and they are a friendly face when they come to church. They are local youth who help the Rainbow Trail Counselors lead the camp program and help with the kids. We had about 10 junior counselors this year that would rotate on which days they were available.

We partnered with many departments throughout the county doing various activities. Some of the activities included the Summit County Fire Department giving us a tour of their truck and answering questions, Friends of Dillon Ranger District teaching us about forest safety and facts, and the Summit READ dogs and Summit Animal Shelter telling us how pets can help others. The children learned about our labyrinth and had an opportunity to walk it. On Friday, our last day, we hung out at Rainbow Park with the counselors and went swimming at the Silverthorne Rec Center.

On Thursday afternoon we put on a show for the parents. The kids and counselors told the parents what they have been learning in Bible study for the week. They also sang the songs they had learned. It was a nice chance to gather, share some ice cream sundaes, and talk with each other about the camp and how it has impacted their children. It also was a nice way to invite parents into our church to see and feel what we are about!

The Welcome Bags for all visitors underwent a major improvement this year. They now contain a reusable shopping bag that has the church logo and logistical information printed on the side. They also contain a visitor information card and a copy of LOTM theology statement.

DAYS SERVICES

Day Services are offered at Lord of the Mountains on Wednesday and Friday afternoons from 1:00 to 4:00 p.m. Clients can take a shower, eat a hot lunch, do laundry, charge their electronic devices, make phone calls and use the internet. All clients must have a referral form from FIRC. If a person qualifies for the food bank at FIRC, they are given information about Day Services and a referral form.

Two volunteers are recruited to serve each day. The volunteers arrive at 12:30 p.m. to set up. This includes folding towels, checking supplies, warming food and setting up for lunch. While we have many very dedicated LOTM volunteers, it has been a challenge to fill all of the positions. In response to our need for additional volunteers, Diane Luellen worked through the Interfaith Council to encourage other faith communities to help with Day Services which is truly a community outreach project. Six volunteers have been trained and St. John's has committed to providing volunteers for the fourth Friday of every month.

To encourage more volunteers, the LOTM council made an appeal at a Sunday service and encouraged new volunteers to sign up and work with a current volunteer.

At the beginning of 2018, a new washer was installed so that we now have a large capacity washer and two dryers. In general, three clients can wash and dry a load of clothes before the 4:00 p.m. deadline. If a client is unable to use the washer and there is an urgent need, we will

provide \$4.00 in quarters. They are eligible to receive this assistance only once a week. Volunteers use their discretion when to offer the assistance.

Food for lunch is generally provided by the Community Dinner held on Tuesdays at the Elks Lodge. Regular volunteers pick the food up on Tuesday evenings and deliver it to LOTM. When there is not sufficient food for Day Services, we buy additional food that can be prepared in the microwave or is ready to eat. We also keep food in the freezer that can be given to people in need.

The average number of clients on any given day is 5 or 6; however, the numbers range from 0 to 21. The weather is a factor in the winter when our numbers go down. When the resorts are not operating at capacity, our numbers go up, especially during the summer when people are attracted by the mild weather and opportunities to camp out.

I have reached out to FIRC to see if they can provide a caseworker during the summer months when we have more clients who have more needs, especially referrals for mental health services. I am hopeful of a positive response.

Most of our clients come five or fewer times in a year which indicates that they were experiencing a short-term need. Day Services helped them through the crisis and they moved on or found work and/or housing. Our regulars are often well known to the volunteers. They use Day Services to help make what money they have from odd jobs, panhandling, benefits or family go a little further.

Our clients have varied backgrounds and reasons for seeking assistance. In general, they are very grateful for the help we are able to provide. On their behalf, I would like to express my gratitude to the council and LOTM congregation for your continued support.

SECOND OFFERING SUNDAY

The mission of the Second Offering Sunday (SOS) Team is to serve Lord of the Mountains Church (LOTM) and decide by prayer and consensus which charitable groups we will support with donations of time, talent, or financial aid. The team works to insure there is a balance of local, national, and international causes to which we contribute. These causes generally have some relationship to LOTM and have members of the congregation as "champions" in order insure connection and accountability. TASK FORCE TO REDUCE GUN VIOLENCE

The LOTM Task Force to Reduce Gun Violence has been reduced to a mighty few this year due to members moving away, travelling or becoming ill. We still have continued to support and join with different groups to help with a wide range of activities in 2019. The primary activities have been the following:

- Our LOTM Task Force continued to be a member of Colorado Faith Communities United against Gun Violence (CFCU). Throughout the year, two members of the Task Force attended monthly CFCU meetings in the Denver area. We continue to be a driving force and resource for smaller, rural congregations. It is a moving experience to be at a meeting where so many diverse congregations and people are joining together in a positive way to prevent gun violence. The highlight meeting of the year was Extreme Risk Protection Order (ERPO or Red Flag) Bill Implementation with our own Attorney General Phil Weiser. Through our strong presence and thoughtful questions, we put implementation of ERPO on the radar of policymakers. It was attended by over 180 people from various CFCU member congregations and others. For more information go to http://cfcuco.org/erpo-implementation-meeting-on-oct-15-draws-over-180-attendees. Diane Luellen and Donna Clark had breakfast with Susan Oakes from CFCU to discuss what they could do for us and our congregation, resources available, how we are moving forward, the Interfaith Council, and various other gun violence issues. CFCU holds many vigils, marches, workshops, trainings and meetings that we can be a part of to work toward ending gun violence. http://cfcu-co.org/.
- Our own founder, Diane Luellen, and Lord of the Mountains were featured in the ELCA
 August 9th blog as well as being mentioned on the CFCU website about our work in
 preventing gun violence. You may access this informative question and answer session
 on Congregation Raises Faith Voice Against Gun Violence ELCA Advocacy.
- Throughout the legislative session, our Rapid Response Network used an email messaging system to inform a group of motivated citizens (LOTM members and friends) to communicate with Colorado (and sometimes national) legislators to express their opinions when bills involving firearm possession or use were being considered which could affect the safety of citizens. It just takes a moment and a simple email, so if you wish to be a part of the Rapid Response Network, please contact the LOTM office and give them your email or sign up on the table in the narthex.
- Members of the LOTM Task Force have planned and participated in many events sponsored by the Summit Interfaith Council such as the Summer Sundays Film series on various subjects that are concerns in our county and nation including Gun Violence and the NRA.
- In September our Sanctuary Choir participated in the 2019 #singonesong Concert Across America.org to drown out war-provoking and hateful rhetoric with beautiful voices

singing together. Our Sanctuary Choir joined approximately 5,000 performers participating in approximately 350 events across 43 states by singing "Hallelujah" during the service that day.

CHARITABLE ENDOWMENT FUND

The Charitable Endowment Fund was created 26 years ago for the purpose of expanding and enhancing the mission of Lord of the Mountains beyond the programs and ministries supported by the church's general operating funds. The fund supports causes at the local, national, and international levels. Distributions are granted to 501(c)(3) and other recognized charitable organizations that reflect the mission of Lord of the Mountains.

This year two of our long-time board members retired. Treasurer Dennis Boyd handed over the job to Ron Gebhardtsbauer, and President Bill Musolf retired and was not replaced. There is ongoing conversation about the feasibility of combining our Charitable Endowment Fund with the recently created Legacy Gift Fund. Each fund would remain separate, but the boards would combine. That recommendation will be determined at our combined meeting on January 14, 2020.

The Board also voted unanimously to recommend to the Church Council changing the distribution to 0-8% annually of the money in the fund rather than 0-6% as we currently are doing. The Church Council approved that change at its January, 2020 meeting.

Distributions are granted on a quarterly basis. Suggestions for grants may be given to any board member, the pastor, or the church administrator. The Board welcomes additional contributions and encourages church members to consider the Charitable Endowment Fund in their gift and estate planning.

The Board members who direct the fund are elected by the congregation to 3-year terms. The board members oversee and manage fund investments and distributions. The board currently distributes up to 6% of the average year-end market value of the fund calculated over the prior 3 years.

LEGACY GIFT ENDOWMENT FUND

The Legacy Gift Endowment Fund Committee was formed in 2019 by adoption of an amendment to the LOTM Constitution by the LOTM congregation at the congregational annual meeting.

The committee accomplished the following in the course of 2019:

- Established a close working relationship with the ELCA Foundation, particularly with Tina Kvitek, the Regional Gift Planner for the Rocky Mountain Synod.
- Adopted Gift Planning Guidelines.
- Interviewed candidates for holding investments and selected the ELCA Foundation.
- Developed a brochure for the legacy gift program.
- Made three presentations to the LOTM congregation, and have secured, to date, approximately \$125,000 total in estate planning commitments and cash contributions.

The Committee's 2020 goals are as follows:

- Contact by letter both former LOTM members as well as recently relocated members to ask for their support.
- Select a suitable data base and establish a program to periodically contact donors to thank them for their contributions.
- Since the membership of the Legacy Gift Endowment Fund and the Charitable Endowment Fund overlap, consolidate the membership of the two committees into one combined committee and hold combined meetings.
- Further appeal to the LOTM congregation for support, and build up the cash endowment to at least \$25,000 (the minimum amount required by the ELCA Foundation to establish an account).

SUMMIT COLORADO INTERFAITH COUNCIL

Summit Colorado Interfaith Council strives to promote conversation among the people of Summit County around issues calling for a response to human needs

Beginning just over four years ago with a simple dialogue between two churches, the Council now lists ten faith and service member organizations: LOTM, St. John's Episcopal, Synagogue of the Summit, High Country Unitarian Universalist Fellowship, Father Dyer Methodist, St. Mary's/Our Lady of Peace Catholic, Immanuel Fellowship, Independent Hindu Fellowship, The Church at Agape Outpost and the Senior Center Board. Pastor Liliana and LOTM members continue to play a leading role in all of its planning and activities.

Highlights of 2019 include the following:

- The continuing Summer Sundays Film Series included topics such as housing and homelessness, the impact of gun violence on schools and churches, healthcare issues in American society and growing white nationalism.
- A very moving service of unity held at LOTM with our local Muslim community following the attacks on the Christchurch mosques in New Zealand.
- A second unity service in the St. Johns sanctuary created for the Summit community following the attacks on churches in Sri Lanka.
- The launch of a continuing series of People's Suppers designed to bring diverse groups of Summit County folks together to eat and join in guided discussion about who we are as people
- The success of the Local Overnight Safe Parking Permit Pilot Project was accomplished in partnership with Good Bridge Community and Agape Church.
- The Thanksgiving To Go program delivered approximately 360 bags of holiday groceries to needy families.
- The first annual Interfaith Service of Thanksgiving held November 17 at LOTM included clergy from several congregations, an interfaith choir, two bell choirs, and a woodwind quintet, with approximately 160 people from at least nine faith communities and pie for a standing room only crowd.
- Partnering once again with Building Hope, "Blue Christmas, Living with Darkness and Light" was offered for those who find the holiday season less than joyful because of loss or unhappiness.

In addition, the Council serves as a conduit for information on a variety of community programs: mental health, caregiver resources, immigration issues, aging, environmental issues, health care. Partnering with a host of Summit County groups, we are here to "get the word out" to thousands of individuals in our 10 member organizations. One example was that of securing additional volunteers for our own Day Services.

Congregational (Church) Council

- C12.01. The voting membership of the Congregation Council shall consist of the pastor(s), the officers of the congregation, and up to eight members of the congregation. Any voting member of the congregation may be elected, with the exception of a paid worker, subject only to the limitation on the length of continuous service permitted in that office. A member's place on the Congregation Council shall be declared vacant if the member a) ceases to be a voting member of this congregation or b) is absent from four successive regular meetings of the Congregation Council without cause or c) member resigns from office. Consistent with the laws of the state in which this congregation is incorporated, the congregation may adopt procedures for the removal of a member of the Congregation Council in other circumstances.
- C12.02. The members of the Congregation Council except the pastor(s) shall be elected at the Annual Congregational Meeting to serve for three years or until their successors are elected but not beyond the third annual meeting after the annual meeting at which they were elected. Council members may be reelected for one additional consecutive term. The terms shall begin at the close of the annual meeting at which they are elected. Newly elected Congregation Council members shall be installed at worship the Sunday following the date they assume office.

2019 By the Numbers

- Lutheran Advocacy-CO advocated for 10 bills at the legislature, leveraging \$3.5 million in state funds and \$1.7 million in federal funds
- Lutheran Advocacy Ministry-NM welcomed 160 Lutheran and ecumenical partner advocates at the annual Bishop's Legislative Luncheon.
- Educate, Equip, Enact (3E) saw 22 congregations participate in Stewardship for all Seasons, and 18 rostered ministers received grants to address financial challenges.
- 62 people in the candidacy process are being accompanied from discernment to their first call.
- 14 new members of RMS Youth Council were installed at synod assembly.
- 40 part-time pastors and deacons gathered for a ministry gathering and formed an ongoing network of support and learning for those serving part time calls.
- 303 Zoom videoconference meetings enabled Leaders to connect across our vast geography.
- 47.5% of mission support received in our synod was shared with our Churchwide Organization.


- Convened deacons and synodical leadership at Pacific Lutheran Theological Seminary (PLTS) for a Word & Service Summit.
